## **DID YOU KNOW?**

OUR CITY COUNCIL MEETS **TUESDAY JANUARY 12 @ 6:00 PM** TO CONSIDER REMOVING EL DORADO MHP FROM OUR VOTER-APPROVED MH RENT STABILIZATION ORDINANCE BASED UPON A LONG-TERM LEASE ACTIVELY SOLICITED BY THE CITY'S HIRED "CONSULTANT.

IT IS RUMORED 40-45 EL DORADO HOMEOWNERS HAVE SIGNED A "NEGOTIATED" 15-YEAR LEASE AGREEMENT WHICH IS EXEMPT FROM OUR RENT CONTROL ORDINANCE, AND CONTAINING THE FOLLOWING:

\*ANNUAL RENT INCREASES WHICH EXCEED THE COST OF LIVING FOR M/H PARKS OPERATIONS(CPI) INDEX!

\*THE ABILITY TO MANIPULATE VIRTUALLY UNLIMITED RENT INCREASES UPON RESALE OF THE HOME WHICH SHALL RESULT IN SIGNIFICANT LOSS OF HOME EQUITY (FOR EVERY \$100.00 THAT RENT IS INCREASED EQUITY IS DECREASED BY \$10,000.00)!

\*PASS THROUGH OF CAPITAL IMPROVEMENTS AND REPLACEMENTS ALONG WITH GOVERNMENT MANDATED EXPENSES IN ADDITION TO RENT INCREASES!

\*MANDATORY ARBITRATION WHICH <u>TAKES AWAY THE RIGHT</u> TO SUE THE PARK OWNER FOR ISSUES LIKE "FAILURE TO MAINTAIN" THE PARK INFASTRUCTURE!

DUE TO THESE SIGNED LEASES, THE CITY COUNCIL IS CONSIDERING ADOPTION OF A "**REGULATORY AGREEMENT**" AND A POTENTIALLY UNLAWFUL "AMENDENT" TO THE ORDINANCE THAT WILL **REPEAL** RENT PROTECTION FOR EL DORADO MHP.

**WILL OTHER PARKS BE NEXT?** 

DID THE EL DORADO RESIDENTS WHO SIGNED THESE LEASES KNOW WHAT THEY WERE SIGNING?

WERE THE LEASE PROVISIONS ACCURATELY EXPLAINED TO THEM?

WHAT WILL HAPPEN TO THE EL DORADO RESIDENTS WHO CHOSE NOT TO SIGN THE LEASE? WILL THEY LOSE ORDINANCE PROTECTION?

WE ENCOURAGE YOU TO ATTEND THE COUNCIL MEETING ON JANUARY 12TH AND ADDRESS THE CITY COUNCIL ABOUT YOUR CONCERNS. IT IS YOUR RIGHT AS CITIZENS TO DO SO!
